Discussion - Tazers

Sheriff Timothy Rogers, Lt. James Crawford, Lt. Dean Hettinger, Lt. Chad Jackson and Mrs. Robin Schonauer attended the meeting to discuss some needs at the Sheriff's Office. Sheriff Rogers stated that they have received a donation from the Skelton family for the replacement of some Tasers. He then turned the meeting over to Lt. Hettinger. Lt. Hettinger then stated that the Tasers are old and in need of replacement as they can no longer get parts for the ones they now have. He explained how much the Tasers help and that injuries have been reduced considerably. He gave some examples of where the Tasers have worked very effectively. The Sheriff then stated that there are numerous stories he could tell where the taser has saved lives. It is a necessary tool for the Sheriff's Department. They need 34 total and have funding for approximately 15. Mr. Shryock asked if there is a need for any additional funding other than the Tasers. Sheriff Rogers stated at this time they feel they will be able to work within their budget for 2015. Lt. Crawford stated that they are concerned with the hospital billing for inmates, but other than that, he feels they will meet their budget. Mr. Shryock asked if the Commissioners wanted provide the funding for the remaining 19 Tasers, Mr. Lee made a motion, seconded by Mr. Fischer to provide \$19,811.92 for the remaining Tasers.

Commissary Contract Renewal

Lt. Chad Jackson presented the new Commissary Contract with Keefe. He reviewed the features of the Contract and asked that the Commissioners sign the Contract. The Contract effective date will be August 1, 2015 for a period of 5 years. The agreement is commission based and it will generate some revenue for the general fund. The expense for the service is taken from the sales profit. Mr. Fischer made a motion, seconded by Mr. Lee to sign a 5 year agreement beginning August 1, 2015 with Keefe to supply food and other related products to the inmate commissary at the Coshocton County Justice Center.

2016 CDBG Allocation

Mayor Steve Mercer, Mr. Jerry Stenner and Mrs. Robin Schonauer, Commissioners Budget Director attended the meeting to discuss the 2016 CDBG Grant Allocation. Mr. Shryock stated that they have asked them to attend for an informal discussion on the 2016 CDBG Grants. He stated that we think it will be possible to apply for 2 competitive grants next year. The Commissioners wanted to have conversation with the City of Coshocton early to make certain we meet all the deadlines. This last grant we received for the city was very much needed and we feel there is still much need there. Mayor Mercer stated that the grant that they received this year will not have any issues being completed this spring. He then asked if there was any other interest from other communities in the county. Mr. Shryock stated that there is some interest, but once those entities submit the request, then the Commissioners determine who has the most need at this time. Mayor Mercer stated that they do have a need for the advancement of water into Tuscarawas Township and this would benefit the township as well as the City. He stated that for this area, they anticipate the EPA may have an issue as there is possible contamination in the wells. He stated that in the future, it may need to be expanded and this may be requested in future years. The first phase would affect 72 residents and they are calling the project Sixth Street Phase 1 Water Project. The Mayor then stated that there is an additional \$180,000 that they will need to come up with and they may struggle to do so. Mr. Lee stated that it could be possible to use some of our CDBG Allocation funds for leverage on this project. Mr. Stenner then stated that they do have some other projects that they had engineered to be pro-active in the way of grant funding. He then reviewed some of those projects. Mr. Shryock asked if the project that was first submitted is their main project. Mayor Mercer stated that this would be the most needed project at this time. Mr. Shryock then asked if they have any other projects for neighborhood revitalization, or downtown revitalization. Mayor Mercer stated that they do have a downtown revitalization grant possibility. This project would mainly look at upgrading the lighting for downtown and out across the Three Rivers Bridge. The Commissioners thanked them for attending.
