### ES&S Poll books

Ms. Stephanie Slifko attended the meeting to discuss ES&S Poll Books Memorandum of Understanding. She stated that she needs the Commissioners signature on the Memorandum of Understanding. The Election Board has picked ES&S Poll Books. She stated that the reason they picked ES&S was because of the backup storage. She also stated that they have service within the State of Ohio and encoding was also considered. She then explained that they are hoping to be able to still utilize these Poll Books in the next 5 years. She stated that the State is reimbursing the purchase at 85% for the Poll Books. She also stated that the Board of Elections did purchase additional items and that is why it looks like we are providing more than 15%. Mr. Lee made a motion, seconded by Mr. Fischer to sign a Memorandum of Understanding with the Ohio State Department of Administrative Services in the amount of \$70,359.00 for the Poll Books. The State will reimburse \$37,840.24 and the County will be responsible for \$32,518.76.
