Governor's office of Appalachia

Mr. Jason Wilson, Governor's Office of Appalachia attended the meeting to touch base with the Commissioners. He stated that he is excited about 2016. He discussed the Appalachian Regional Commission Budget and stated that it was funded in full as requested. This is a bi-annual budget. He praised Mrs. Dorothy Skowrunski on her work for the CR 12 project and bringing it to fruition. He stated that when everyone is aligned with the same goal, things can work and very quickly. He then stated that he understands that the county needs an access road at our airport. He stated that they would like to partner with the military to do an IRT (Innovative Readiness Training). This would be an IRT Infrastructure Training. He feels access roads and roads are a perfect place to learn how to do this and they would like to bring them to Ohio to do these types of programs. He stated that this would be a perfect opportunity for the county. He stated that they will present 10 projects to the ARC and one will be the access road at the County Airport. There will be costs in the materials for the project that would be the responsibility of the county or the airport board. This project would fall under an Infrastructure IRT. They feel very confident that they will be able to make this project work. It would be late 2016 or early 2017 when the project would start. He also wanted to share one other program they are working on and that is the Abandoned Gas Station Monies. The state has put 20 million dollars toward this project. The goal is to put these properties back into use as viable properties. He then asked the Commissioners to update him on the CR 10 project. Mr. Shryock stated it is very similar to the CR 12 Project. It is quite evident that the traffic on the road for that area is quite different because of the Amish buggies on this road. We are seeing a lot of Amish business expansion in that area as well. Mr. Shryock stated that this board has nothing but praise for Mrs. Skowrunski. The CR 12 Project has reflected her hard work and abilities. Mr. Wilson then stated that the gas and oil industry is growing exponentially. They are very optimistic about this industry. This is a key industry in our region and there is a whole new dimension of support in the way of philanthropy. Mr. Fischer thanked him for working with Mrs. Skowrunski and they appreciate that there is interest in looking for a solution to our issue with the airport access road. Mr. Wilson then discussed monies set aside for the coal affected states in the Appalachian region. He stated that it could be between 2 and 5 million dollars for Ohio. These funds would be for worker training and to make sites ready for some other type of business. This is called the Power Plus Initiative. He also stated that this will be sustainable monies as well. He feels it may last up to 10 years. That being all, the Commissioners thanked him for attending.


