#### 2015 Annual Dog Wardens Report

Mr. Russell Dreher attended the meeting to present the Commissioners with his 2015 Annual Dog Wardens Report. He reviewed 2015 and also gave a comparison with 2014. He stated that overall, they have picked up 100 less dogs this year and citations have increased. The total dogs sold decreased a little and that is because they are taking in less dogs. Mr. Shryock asked how many of their citations or court cases did they lose. Mr. Dreher stated that they did not have any that were lost. He talked about equipment purchased in 2015 and how they were able to utilize the additional equipment purchased. He then talked about the monies spent on the Animal Shelter and the maintenance and update he is doing out there. He stated that next year he would like to start on the process of replacing fencing on the kennels, closing in a couple kennels and some other needed projects. He reviewed the part-time hours of himself and the Assistant Dog Warden. Mr. Shryock stated that when he introduced this change to the program, the county was only selling around 4500 dog tags per year. Now, we sold 8510 in 2015. He praised Mr. Dreher for their implementation of the program and stated that he did speak with the Sheriff and he had nothing but praise for the Dog Warden Program and what the employees are doing there. The Commissioners praised the Dog Wardens for their work and asked them to continue as they have been. The Commissioners thanked him for attending.

## EMS Request for Bargaining Unit

Mr. Todd Shroyer attended the meeting to discuss the notice he received from the State Personnel Review Board. He stated that we received an official request for recognition a week ago Monday, and then just this past Monday, we received an amendment to the original request. He spoke with our attorney and he stated that he will proceed to file the needed paperwork. He wanted to update the Commissioners on where things are at this time. He then stated that this request will affect all full-time EMT's, and Paramedics excluding part-time EMT's, supervisors and the Director. He stated that there are still some other administrative employees that are in question. The Commissioners thanked him for his update.
