Discussion - Mr. Tom Edwards - Sales Tax Holiday

Mr. Tom Edwards requested a meeting with the Commissioners to discuss the Sales Tax Holiday offered by the State of Ohio. Mr. Edwards stated that he was here to discuss the House Bill 264 which is a bill that will allow a Sales Tax Holiday. He feels that this law is too vague and will allow for real concerns in who is deciding what educational purposes are. He then stated that Sales Tax is set up to support local government funds. He also stated that there is a section of the revised code that states the county has a portion of the sales tax they can put on and they have full authority as to its collection and use. He fees that the State of Ohio is taking the monies away from the local governments by making a Sales Tax Holiday. He feels the legislature should do away with the Sales Tax Holiday and start making certain the residents are paying sales tax on items purchased on line. Mr. Shryock explained that the County Commissioners Association of Ohio did testify to the legislature representing all County Commissioners in the State of Ohio and do not support this holiday. Mr. Edwards stated that he hopes the Commissioners Association has luck with their appeal. He thanked the Commissioners for listening to him.
