Monthly Transport Expense Report

Received the Monthly Transport Expense Report for the month of February 2016 from Coshocton County Sheriff Timothy Rogers

House Bill 64 – Animal Claim Law Change

Mr. Russell Dreher attended the meeting to inform the Commissioners of House Bill 64 and the change to the animal claim law. Mr. Dreher stated that this went into effect towards the end of 2015. He then stated that it is important to get this information out to the public. He stated that anytime livestock is killed by a predator or dog the dog warden investigates the claim and determines the nature of the kill and if it is determined that it is a coyote or some other predator kill, they notify the State of Ohio, if they determine that it is a dog kill, they are permitted to pay a claim through the Dog and Kennel funds. However, if they determine the owner of the dog committing the offense, then the owner must pay restitution. With the change to the law, the dog warden will investigate the nature of the kill and it will now be up to the livestock owner to file a civil complaint for restitution. The Dog and Kennel fund is no longer permitted to pay the claim. He then reviewed the previous years and the number of claims that were paid by the Dog and Kennel fund as well as the number of claims paid by dog owner for restitution. Mr. Dreher stated that he was against this change as it gave the dog warden incentive to go out and solve the claim and now it takes that away. Mr. Fischer asked if the numbers were up statewide as to cause the change. Mr. Dreher stated not that he was aware. Mr. Shryock asked if there was any way we can continue as in the past and Mr. Dreher stated that they removed all that ability. The Commissioners thanked him for his information.

Records Commission

Ms. Janet Mosier, Mrs. Susan Turner, Ms. Christine Sycks, Mr. Jed McCoy, Mrs. Breanne Smith, Ms. Lindsey McCullough, and Mr. Jason Given attended the meeting. Minutes from the last meeting were read. Ms. Sycks made a motion, seconded by Mrs. Turner to approve the minutes. The motion carried. Mr. Lee asked for requests for disposals. Mrs. Breanne Smith presented a request for a one time disposal for the Treasurer's Office. Mr. Shryock made a motion, seconded by Mr. Given to accept the request and send it on to the State. Mrs. Turner made a motion, seconded by Mr. Given to adjourn. All vote aye. The motion carried.


