1st Public Hearing – 2016 CDBG Grant Application

Mr. John Cleek, CDC of Ohio, Mrs. Robin Schonauer, Budget Director, Mr. Larry Corbett, Tuscarawas Township Trustee and Mr. John Corbett attended the public hearing. Mr. Lee opened the public hearing and turned the meeting over to Mr. Cleek. Mr. Cleek distributed handouts to all in attendance and introduced himself. He reviewed the PY 2016 Community Block Grant Programs and explained that they are broken down into 3 areas; Community Housing Improvement, Homelessness and the Community and Economic Development Program. This includes the CDBG Allocation and Coshocton County will receive \$111,000.00 this year. He explained that to be eligible for these allocation funds, areas must meet the low to moderate income requirement or the slum and blight requirement. He then stated that the county would be able to apply for competitive programs as well and then explained that process. He stated that we hope that the county will be in position to apply for 2 of the competitive grants this year. That being all, Mr. Lee closed the public hearing and thanked everyone for attending.

Mr. Ken Fisher – Construction Law Attorney



Adjourn


Mr. Lee adjourned the meeting at 4:00 p.m.
