Discussion Emergency Operations Plan

Mr. Rob McMasters and Mr. Troy Cole, Emergency Management attended the meeting to discuss the updated Emergency Operations Plan. Mr. McMasters stated that there was not a lot that needed to be done with the plan to update it at this time. He presented the Commissioners with a draft plan and he stated that he made a couple adjustments in the plan. He then reviewed these adjustments. He suggested that once the plan is adopted that we set in place a practice and review policy. Mr. Shryock stated that will make it difficult for some offices to set specific dates for practices and reviews. Mr. McMasters stated that he understands this and would suggest that this be individualized for each department. Mr. Cole suggested practices being done a couple times per year. Mr. Shryock stated that he does not have a problem with the practice, but it will be up to each elected official and department head as to how, when or if they want it to happen. Mr. McMasters stated that he would like to train some County Employees to help in these emergency situations as he feels this would be beneficial to the County in case there was an emergency. He would also utilize them if there are any disasters throughout the county as well. Mr. Shryock made a few suggestions to some changes for the plan. Mr. Fischer stated that he was in agreement with Mr. Shryock in that we need to put a broad statement at the beginning of the plan stating that this plan should be reviewed and practiced annually. Mr. Lee stated that he feels that each department should get a copy of the draft plan and he asked them to bring it to the meeting with them on Wednesday for any suggestions. Mr. McMasters stated that they will make the suggested changes, send it to all departments and then sometime next week or so we will adopt the final plan. The Commissioners thanked them for attending.
