Public Hearing - PY 2016 CDBG/Critical Infrastructure Grant Process

Mr. Lee opened the public hearing at 10:30 a.m. Mrs. Robin Schonauer, Commissioners Budget Director and Mr. John Cleek, CDC of Ohio attended the hearing. Mr. Cleek stated that the County will get \$111,000 in Allocation funds. We have designated \$60,000 to the City of Coshocton for Sanitary Sewer Projects, \$22,600 for home demolition in the County and 22,200 for Administration. In addition to that we will apply for Critical infrastructure funds for the City of Coshocton in the amount of \$300,000.00. Also, we will be applying for \$83,000 in Critical Infrastructure for a new bridge in the Village of Nellie as well as \$6,200 in CDBG matching funds for this bridge for the Village. Mr. Cleek stated that he will submit the application by next week and we should hear something by September of this year. At 10:50 a.m. Mr. Lee closed the public hearing.
