Kimble County Recycling Trailer Drop-off

Mr. Jeff Wherley attended the meeting to update the Commissioners on his discussion with Kimble about the possibility of utilizing their company for our Recycling Trailer Drop-off. Mr. Wherley stated that since the Rumpke Mt. Vernon site will be closing at the end of this year, he went to look at the Kimble site in Dover. He feels this may be the best solution. His only concern is that Kimble will charge us a fee to utilize their site. He does not know what the expense would be at this time, but will make certain we have this information in the very near future. He stated that he would like to continue to utilize Rumpke until the end of the year, but would like to have something in place for next year. Mr. Lee asked if this would be farther than where we are going now. Mr. Wherley stated that the distance is really about a wash and there should really be no difference. The Commissioners asked Mr. Wherley to get the information from Kimble to proceed and we can move forward with a contract. Mr. Lee then asked where we are on the Armory recycling site that needed to be bid. Mr. Wherley stated that he will check with Mrs. Schonauer to see if we are ready to advertise the bid and set-up a bid opening date. Mr. Lee stated that we need to have a contract in place with the City of Coshocton as well. Mr. Wherley stated that he will take care of this. The Commissioners thanked him for attending.


