The second contract is for the OPTIMAN Contract. He stated that AT&T has come out with a new service and are moving all OPTIMAN contracts to this new service. This will give the county a \$600 reduction per month in our contract. The last contract is for the Animal Shelter. AT&T is proposing an increase to \$350 per month. With that being said Mike went back to AT&T to see if he could get them included on our new OPTIMAN contract. He stated that there will be a one-time fee for this activation and we will need to get the line into the building. Mrs. Schonauer said that with the other savings, we will still be ahead. The Commissioners stated that they do not have any issue with these contracts. Mr. Shryock made a motion, seconded by Mr. Fischer to sign the AT&T contracts that were presented by Mr. Mike LaVigne for their signature.
