Mr. Jeff Wherley - Bid Award - Recycling MRF/Transfer Station Services

Mr. Jeff Wherley attended the meeting to recommend the Commissioners award the Bid for the MRF/Transfer Station Services to Kimble with a bid of \$47.16 per ton and adjusted monthly based on the market. Mr. Wherley stated that with the distance traveled and the number of trips being made per day the Kimble proposal will work the best for Coshocton. Mr. Lee stated that even though the Kimble bid is higher, with the distance and the number of pulls per day being made, it will be less expensive to go to the Kimble sight.

Mr. Fischer made a motion, seconded by Mr. Shryock to award the bid for the Recycling MRF/Transfer Station Services to Kimble with a bid of \$47.16 per ton monthly based on the market for one year beginning January 1, 2017 with an option to continue. Even though the Kimble bid is higher, it will be less expensive to go to the Kimble sight due to the number of pulls being made per day and the distance traveled.

Discussion – Animal Shelter

Mr. Rusty Dreher attended the meeting to request permission to do some fencing on the kennels at the Animal Shelter. He stated that he requested several options from Creekside Vinyl LLC. He reviewed the options and stated that he would like to do option 1 immediately and it will be \$3,093.00 to replace the chain link fence inside the kennels. He then stated that he would like to work with the Humane Society to put in \$5,000 and the Dog and Kennel Fund would supply approximately \$8,000 to complete the other 4 options. This would take care of all the issues with fencing at the Animal Shelter. Mr. Shryock asked if the estimate included installation. Mr. Dreher stated that it did include installation. Mr. Lee asked how long the estimate is good for. Mr. Dreher stated that it is good for 30 days but, he spoke with Creekside and they told him it may vary a couple hundred dollars or so if the remaining options are not finished until next year. The Commissioners are in agreement with his plan. The Commissioners thanked him for attending.
