2017 Budget Meeting

Mrs. Robin Schonauer, Mrs. Tiffany Swigert, Mr. Rob McMasters, Mrs. Stephanie Slifko, Mrs. Kirsten Ross, Mrs. Susan Turner, Ms. Deb Bigelow, Mr. Mark Chaffin, Mrs. Stephanie Hawkins, Mr. Doug Schonauer, Mrs. Breanne Smith, Judge Robert Batchelor, Ms. Barbara Powell, Mrs. Melinda Fehrman, Mr. Danny Brenneman, Mr. Jim Barstow, Ms. Christine Sycks, Mrs. Jinni Bowman, Mrs. Nicole Medley, Mrs. Sheila Reger, Mr. Todd Shroyer, Ms. Camila Graham and Ms. Janet Mosier attended the meeting. Mr. Lee opened the meeting and stated that we are approximately around \$400,000 less than we ended last year with. The \$800,000 that we had set aside for the new Justice Center has been put back into the budget for 2017. Mr. Lee then explained the change of how we will be paying Workers Compensation this year. Mrs. Swigert stated that we chose this payment option because of the savings that we will get from it. She then explained how the charge backs to the non-general fund departments would work. Mr. Lee then stated that we will also be reducing some of the Commissioners line items as far as Maintenance and Capital Improvements go. Also, this year we will only be giving departments their expended health benefits for 2016 as their 2017 budget amount. However, if they need additional funding for this line item, the Commissioners will give them additional funding in that line item. He also stated that if you have salary increases in the June estimated budgets they are not discouraging that they give those increases. He touched on the sales tax loss due to the Medicare/Medicaid MCO loss. Mr. Fischer then stated that there are some things out there that we just don't know about yet. Mr. Lee then stated that last week we passed a resolution for the 2017 Temporary Appropriations. Judge Batchelor asked that if we get an answer on the Sales Tax that is not good, please make certain we know as soon as possible. Ms. Sycks stated that she feels for next year we will be alright on the sales tax. Mr. Lee reiterated that if anyone has any retirements or anything they will need additional funds for to please get with Mrs. Schonauer. The Commissioners thanked them for attending.
