Discussion - Tire Removal - County Barn

Mr. Jeff Wherley attended the meeting at the request of the Commissioners to discuss the tire removal for the County Barn. Mr. Fischer stated that it was brought to our attention that we are having problems getting the vendor to come and get these tires. Mr. Wherley stated that he was made aware of the situation mid-December. He has been reaching out to almost anyone he could think of, but has not had any luck in finding anyone else. Mr. Lee stated that from what he understood the company was scheduling a time to come and never would show-up. Mr. Wherley stated that he is working with Coshocton Trucking to get them to come and get the tires and take them to a collection facility. There will be a cost for the hauling and there will be a cost to the facility they take it to as well. Mr. Lee had some concerns that once the tires are hauled to the facility, would the facility even take them if they don't have room. Mr. Wherley stated that he feels that if we can get them hauled to a facility, they will take them. Mr. Shryock stated that we should probably look into a box truck to store the tires until we can get them hauled away. Mr. Wherley stated that he will check into this and get back with the Commissioners. Mr. Wherley then stated that he has been working on the OEPA Grant for a packer truck for the county. He stated that he feels this may work for the county in many ways. Not only for the Recycling Sites, but this could work for our tires being hauled away too. Mr. Shryock stated that he understands that this grant is a 50% match. He questioned the ability to come up with the match monies. Mr. Wherley assured the Commissioners that we have enough match monies for this. Mr. Shryock stated that his only concern with this is what happens when it comes time that we need to buy a new truck. The Commissioners stated that they would like him to talk with the Solid Waste District to make certain they are on board with this plan. The Commissioners look forward to hearing from him.
