Mr. Steve Silverwood, Mr. Phillip Silverwood and Mrs. Tiffany Swigert, Regional Planning attended the meeting to discuss Mr. Phillip Silverwood's property in Tiverton Township. Mrs. Swigert explained that there is an 11 acre strip of property that was canal land and deeded to the County back in 1899. However, Mr. Silverman has a deed that states that they own all that property. Their deed was later than the deed that is referenced above. She stated that research was done last year to locate the deed for this unidentified property. She stated that she will need to work with Jetta Mencer from the County Auditor's Office to determine how she found this as well as how we should proceed. Mr. Silverwood stated that they have done title searches that goes back 150 years and they all say the same thing. That the property he owns goes to the center of the Mohican River. There is no mention of the County owning the property. Mr. Silverwood stated that they have owned the property since 1973 and they have never heard of the County owning this property. He said at this point, they are land locked due to this deed that has suddenly appeared. Mr. Fischer stated that this property is clearly no benefit to the County and we will contact the Prosecuting Attorney to see if we can find a quick solution to this issue. Mrs. Swigert will work with the Silverwood's and keep the Commissioners abreast of the situation.

Mr. LaVigne attended the meeting and updated the Commissioners on the County IT Program.

Mr. Shryock made a motion, seconded by Mr. Lee to sign a letter of support for the City of Coshocton Recreational Trails Project grant application with the Ohio Public Works Clean Ohio Fund Green Space Recreational Trails Project.


