## Resolution 2017-28

Mr. Shryock made a motion, seconded by Mr. Lee to sign Resolution 2017-28 to levy a tax in excess of the ten mill limitation for the purpose of operation of community programs and services authorized by the county board of development disabilities, for acquisition, construction, renovation, financing, maintenance and operation of developmental disabilities facilities, or for both such purposes at a rate of \$.028 cents for each one hundred dollars of valuation in the amount of 2.80 mills for a continuing period of time. The levy type is replacement with an increase.


## Discussion – Regional Planning Duties and Responsibilities of the Board of County Commissioners
