#### Radio Repair - IT

Mr. Mike LaVigne attended the meeting at the request of the Commissioners to discuss some requested radio repair purchases. Mr. Shryock stated that he has concerns about working on radios when we have programs out there that need to be completed and are being put on the back burner. He stated that it is easy to gravitate to what is needed immediately and overlook some of what people think is less important. Mr. Fischer asked if this is delaying his IT work. Mr. LaVigne stated that he works on the radios in his spare time and it is not affecting his IT work. Mr. Fischer stated that he understands that the Dog Warden Program that they have been working on for the last couple years is still not completed. Mr. Shryock asked what kind of work load he is looking at to take care of these radios as this program is just in its infancy. He asked if this is financially in our

best interest to have our IT Department working on these radios. Mr. LaVigne stated that the cost is only approximately \$900 for the tools. Mr. Shryock stated that it is not necessarily the cost for the tools, it is the convenience of being available at all times and he is concerned that it will affect our ability to get all the IT work done. He is concerned that we are getting too much on our plate and our IT department will suffer. Mr. Fischer stated that he has the same concerns. Mr. LaVigne stated that he is the middleman between the County and the State and he is just trying to please everyone. He stated that he is alright with doing whatever the Commissioners decide. Mr. Fischer stated that they are just concerned that he is getting over utilized with the radios and we need to move to a different option to make certain other issues are not getting overlooked. Mr. Shryock stated that he is just concerned that our IT work will suffer if we continue down this path of radio repair. It was decided to go ahead and buy the radio repair tools and the Commissioners stressed that Mr. LaVigne's primary goal is to address the IT needs of the county and the radio repairs are to be treated as secondary as there are outside vendors that can address these needs. They also stated that they need to have a meeting in the future with the agencies asking Mr. LaVigne to repair the radios to discuss the other available options for these repairs.
