Tuscarawas Township Storm Sewer Discussion

Mr. Don Wells and Mr. Larry Corbett attended the meeting to discuss a storm sewer issue on South 6th Street in Tuscarawas Township. Mr. Wells stated that in the past 10years they have put in a lot of storm sewer drainage. They have a project in the area of 6th Street, Bank Street and Plum Street. This is a bigger project than they can do and he was told by our grant administrator to talk with the Commissioners about grant funding for this project. Mr. Lee stated that he would guess that he is talking about a Critical Infrastructure Grant. Mr. Wells stated that it is a Low to Moderate Income (LMI) area and would qualify. He also stated that they are hoping to utilize some match monies from OPWC which would be over \$100,000.00. Mr. Shryock asked if they would have any other match monies. Mr. Wells stated that they always match the OPWC monies at 50%. Mr. Wells then stated that he discussed this with the Prosecuting Attorney and they will possibly need to have an assessment for the maintenance of the storm sewer system after it is put in place. Mr. Shryock asked if they are replacing an existing system. Mr. Wells stated that there is a system in some places. However, there are only French drains in some placed and no drains at all in some places. This would fix all of this problem. He estimated that the project would cost around \$300,000.00. But, he asked the Commissioners not to hold him to that number as there has been no engineering done on this as of yet. He stated that he is just here to get this discussion and possibly the process started. The Commissioners stated that they will have further discussion with our grant administrator and get back with Tuscarawas Township. The Commissioners thanked them for attending.
