
## Discussion – Recycling


Mr. Max Crown, Coshocton City Services Director and Ms. Leslie Visser, West Rock, Columbus and Mrs. Tammi Rogers, Coshocton Recycling & Litter Prevention attended the meeting to discuss the recycling issues we have had since West Rock has left our community. West Rock is one of the largest recyclers of office and corrugated paper in the world. Ms. Visser stated that they will bail corrugated paper and office paper and sell it to companies. Mr. Lee asked how this would work. She stated that they would look at what we are doing and determine how they could assist us. She stated that once we bail it, they would then come and retrieve it from us. She said it would really depend on what our capabilities are and then they will determine how they can assist us. Mr. Shryock asked if 6 -8 ton per week is a good volume. She stated that it is decent and there are different ways that we could store things before they come pick it up or there are other options. She stated that it is hard to tell them how it would work when she really doesn't know for certain what we have to offer. She presented the Commissioners with a handout explaining how West Rock works and stated that our locality would enable them to work with us pretty easily. Mr. Shryock stated that we are planning to change our whole process for the way we run our program. He stated that we are considering changing the process of co-mingled vs. separation of products. Mr. Shryock then asked if this would work with the market in place now. Ms. Visser stated that she feels that things are good at this time. Mr. Shryock stated that we are trying to determine if this will be cost effective for us to try to move in this direction with our program. Ms. Visser stated that while the corrugated market is stable right now, the mixed paper market is not. So, the Commissioners will need to determine how this would affect us. Mr. Crown stated that once they educated people on what was accepted, then they had a very clean stream. Mr. Shryock asked if they do this in other communities. She stated that they provide equipment and other things to communities to get a clean corrugated pack to send to mills. Ms. Visser invited everyone to see their facility. Mrs. Rogers stated that she would very much like to tour their facility. Ms. Visser volunteered to walk through and look at how our program is being run and offer suggestions in ways to make our program marketable. The Commissioners stated that they will take her up on that offer and then they thanked everyone for attending.
