#### New Justice Center Discussion

Mr. Ken Fischer, Construction Attorney attended the meeting to discuss where the County is on our talks about a new justice facility and what the cost will be to go to the next step. Mr. Fischer asked if everything we have done to date, will be in place for the next 5 years. Mr. Ken Fisher stated that is correct. Mr. Fischer then stated that we still have a very serious over population of our Justice Facility. Today's total in the facility is 69 and that is lower than it has been in recent months. Mr. Fischer asked him what the next step in the process would be. Mr. Ken Fisher stated that we have a contract at this time with Wachtel & McAnally as the county's architect for this project. He stated that we are at the stage to determine exactly where the Commissioners want to go with this project. Determining the type of facility and the number of beds that would be needed. He stated that we can engage the Architect to determine the cost of what we are looking at for our facility. Mr.

Fischer then asked if it would be a good idea to do the environmental studies for the project next or would this not be a necessary expense. Mr. Ken Fisher stated that if we are certain of our site selection then he feels this would be a very necessary expenditure as he feels this would help determine the new building needs. Mr. Shryock asked how far down the road can we go until we get to the Construction Manager at Risk (CMR). Mr. Ken Fisher stated that right now we just have an idea of what the project needs to be, but until we have the program of requirements for the project, we would not be ready for the Construction Manager at Risk (CMR). He stated that with Wachtel & McAnally as architects, he feels we can go pretty far before contracting a CMR. Mr. Shryock asked where construction costs are right now. He stated that CMR fees are running in the 2-3 percent range but he feels we will see an upward trend to those percentages. He also stated that everyone is pretty busy and they are having trouble finding laborers at this time, which will possibly increase costs. Mr. Shryock stated that this is not something we want to do, but we are busting at the seams in our Justice Center and we have to have a place to put these individuals. With that being said, resident's expectations are not necessarily the same as the State requirements. He also stated that to send 10 inmates to be housed outside our facility for a year will cost us around \$250,000 and that was the cheapest place we could find. Mr. Shryock stated that we have challenged the Jail Administration to determine if we build a bigger facility, could we use the additional beds to help with the costs to run a new facility here. Mr. Fischer stated that we have recently had meetings with our State Representatives and Senators to try to come up with a plan to help financially with this needed facility. He reiterated that our intent to have Mr. Ken Fisher here today was to determine what the next step in the process is and how do we get to that stage. Mr. Ken Fisher stated that we have signed a contract with the architect and he feels we should meet with them to determine what the next step in the process is and how we should proceed if possible. The Commissioners thanked Mr. Ken Fisher for attending the meeting and the information.
