#### **EMS-Levy Overview**

Mr. Todd Shroyer, EMS Director and Kayla Chapman attended the meeting to give an overview of the EMS levy that will be on the May ballot. Mr. Shryock asked Mr. Shroyer where we are at with the Campaign effort for the EMS Levy. Mr. Shroyer stated that they are in the process of getting their committee together to start the campaign efforts. He plans to be on the radio next week, he will be at the fish fry scheduled at the Elks which is a blood drive event. He will also be doing door to door flyers. The EMS Levy Campaign will state that we desperately need to add a five crew, as the call volume is increasing. Mr. Shryock stated we currently have three mills on for EMS and he asked what he was asking for. Mr. Shroyer stated that he would be asking for a new additional one mill. Mr. Shroyer stated to put a new crew on the road it will cost him approximately \$60.00 per hour just for staffing. This does not include the vehicle or equipment. The total annual cost for the fifth crew for seven employees is \$525,000 per year. If this levy passes this will put EMS staffing back to where we were five years ago.
