Mr. LaVigne then discussed the County's Time Warner fiber for the Village of West Lafayette. He stated that the county will be required to pay-off a balance once the Village of West Lafayette terminates their agreement with the county on April 30<sup>th</sup>. He stated that we would have to pay approximately \$2,437.50 to Time Warner at that time to get out of this contract we have with them. Or, we could move it and there would be no additional charge other than what we pay at this time per month. He suggested moving the fiber to the newly purchased EMS building on Main Street. Mr. Shryock asked if Mr. Shroyer had a need for that fiber at this time. Mr. LaVigne stated that the EMS is conducting training classes in that building at this time. The Commissioners will take this under advisement and get back with Mr. LaVigne on this issue.
