Dog Wardens Report

Received the Dog Wardens Report for the week ending May 14, 2018 with 5 dogs picked up by the warden, 4 dogs brought in as strays, 1 dog destroyed, 8 dog licenses sold, 3 late fees paid, 4 dogs sold, 4 dogs redeemed, 2 dogs per owner surrender, \$15.00 in boarding fees collected, 4 citations issued, 41 calls handled for a total of \$302.00 in fees collected.

Justice Center Tour

The Commissioners and Mrs. Beck toured the Justice Center to see the improvements that were made.

Walnut Street Parking Lot

Mrs. Susan Turner, Ms. Christine Sycks, Mrs. Janette Donaker and Mr. Frederick T. Wachtel attended the meeting to discuss the employee parking lot on Walnut Street. Mr. Shryock stated that ITM Marketing has requested to lease our parking lot on Walnut Street. He stated that we do have a couple employees and County vehicles that park back there. However, to keep ITM Marketing here, the Commissioners decided to lease the parking lot to them. With that being said, we are leasing some parking spaces from Home Loan Savings Bank to help alleviate this issue. Ms. Sycks asked to have the spaces that we lease to be marked so county employees know where to park. The Commissioners stated that they will ask that this be done. Mrs. Turner asked when this would be effective and Mr. Shryock stated that as soon as we can find out, we will let them know. The Commissioners thanked everyone for attending.

211 Directory

Mrs. Lyn Mizer, United Way, Ms. Diane Gatto, United Way of Greater Cleveland, Mr. Nick Roman, Ohio United Way and Mrs. Susan Turner, United Way Board Member attended the meeting to discuss the 211 Directory with the Commissioners. Mrs. Mizer stated that we received 3 free years to start the data base for the 211 Directory 5 years ago. Currently they are contracted with Cleveland United Way. The cost of this service is \$7,000 annually and in the past 2 years the Department of Job and Family Services have paid \$3,500 and the United Way has paid \$3,500. She stated that this is not just a directory, but a way for the operator to give the caller a way to help get themselves on their feet. Ms. Gatto stated that 211 gives residents on nice answer point for information and services in a community. They are able to assess the residents need and how to best direct them to a community resource. She would love to see this benefit to our community continue. Mr. Roman stated that historically the Ohio United Way helped Coshocton County get our original grant for \$53,000 to Coshocton for this service. He hopes that they can continue this service. Mrs. Mizer stated that she feels if they can keep this service here it might help those working poor individuals that are just one crisis away from losing all hope. Mr. Shryock asked how many people used this service in the last year. Mrs. Mizer stated that last year, we had approximately 500 calls, but this year she anticipates that will increase considerably. Mr. Shryock then asked how funding is provided for this service in other areas. Ms. Gatto stated that they get their funding from many different ways, Job and Family Services, Health Departments as well as Commissioners. Mrs. Mizer stated that they did not need an answer today, but the contract does run out in June. The Commissioners thanked them for attending and stated that they will get back with them.

Security Issues – Justice Center

Mr. Charles Udischas attended the meeting to discuss some security issues that have occurred at the Coshocton County Justice Center.
