Vehicle Maintenance Proposals

The Commissioners reviewed the Vehicle Maintenance Proposals that they received for the maintenance of the Sheriff cruisers and other county owned vehicles with Lieutenant James Crawford and Lieutenant Dean Hettinger. The Commissioners received three proposals from the following businesses: G & M Automotive LLC, Killbuck Valley Auto and Mission Auto Connection. G & M had a proposal for \$50.00 an hour flat rate and \$29.95 for an oil change. Killbuck Valley Auto had a proposal for \$50.00 an hour and had referrals from other area businesses, they also wrote in their proposal that they would be willing to pick up the vehicles for services free of charge. Mission Auto had a proposal of \$65.00 an hour. Lieutenant Hettinger voiced concerns about the distance away with Killbuck Valley Auto was and having Mr. Conrad driving their vehicle that distance. Lieutenant Crawford would like to reach out to Starbrite Quick Lube for pricing on oil changes with the permission from the Commissioner's. Mr. Lee and Mr. Fischer have no issue with checking prices. General discussion was had on vehicle service records. Lieutenant Hettinger also will reach out to Drennen Ford to get fleet prices as well. The Commissioners will wait to hear back from Sheriff's office before a final decision is made.
