2.8 Mill Levy – Board of DD

Mr. Steve Oster and Mr. Robert Mahle, Board off DD attended the meeting to discuss the Board of DD asking the Commissioners to renew a 2.8 Mill Levy for 10 years. Mr. Oster stated that the levy is due for renewal and they can go on this fall, next spring or next fall. They are requesting to put it on the November 2018 ballot. This levy will generate 1.7 million dollars annually and they are requesting this for a 10 year period. This has been in place for 15 years. It has previously been a 5 year levy renewal. This is in addition to the continuing levy. This levy is just to provide services. With that being all, the Commissioners stated they will request Auditor certification once we get the correct language for the levy. Then The Commissioners will determine if they will put it on the ballot in November. The Commissioners thanked them for attending.
