County Services Building Roof

Mr. Dennis Lowe, Building Consultant and Mr. Pat Kelly, Kelly Architectural attended the meeting to discuss the County Services Roof Project. Mr. Kelly presented the Commissioners with a letter of recommendation for the project. He reviewed the bids and stated that overall Architectural Roofing Contractors, Inc. was the low bidder. He explained his recommendation for the thicker insulation over the thinner. He feels that the Commissioners can go with the TPO or the EPDM as they are very similar in price and repair. Mr. Shryock asked Mr. Lowe his recommendation and he stated that as Mr. Kelly stated either one is very comparable. Mr. Kelly stated that he feels that the final cost for the project would be right around \$245,000.00.

Mr. Lee made a motion, seconded by Mr. Fischer to award the bid for the County Services Roof Project to Architectural Roofing Contractors, Inc. with a low bid of \$225,250.00 and a contingency built in making the total expected cost for the project \$245,000.00 as recommended by Mr. Pat Kelly, Kelly Architectural Services.
