Public Hearing – 2018 Budget/Resolution 2018-28

At 9:00 a.m. Mr. Shryock opened the Budget Hearing. Mrs. Robin Schonauer was in attendance. The total General Fund budget requested was \$12,261,204 and Other Funds requested \$34,451,002. The estimated revenue for 2018 is \$10,113,116. Mrs. Schonauer is estimating a carryover of \$3,159,829. Once you take into account the outstanding purchase orders of over \$500,000 that leaves an unappropriated amount of approximately \$450,000. Mrs. Schonauer has major concerns for 2020. Without the MCO monies, we will be short approximately 1 million dollars or more. Mr. Lee made a motion, seconded by Mr. Fischer to sign Resolution 2018-28 to submit the Annual Budget for Fiscal Year commencing on January 1, 2019 to the Coshocton County Budget Commission for their consideration.
