Phase II 911 Upgrade

Lieutenant James Crawford attended the meeting to discuss the Phase II 911 upgrade proposal. Phase I equipment is on sight, ready to be installed next week. By September 12th they will be live with Phase I which is the answering monitor for the 911 lines coming in as well as the text to 911 and this will meet our compliance with the state. We could have lost over 90,000 annually if we did not do the upgrade to meet all 911 mandates. Phase II, will be the mapping and GPS portion of the upgrade. Phase II proposal will cost \$308,743.00. Phase II will be financed for 7 years with an annual payment of approximately \$55,000.00. Lieutenant Crawford asked the Commissioners to approve a change order for an increase on Phase I; the ProQA quote has an increase. Mr. Shryock made a motion, second by Mr. Lee to approve a Change order on the ProQA quote for Phase I for \$2,736. The Commissioners gave Lieutenant Crawford permission to move forward with financing on Phase II. Once financing is in place the Commissioner will approve the Phase II upgrade proposal.

Discussion-Todd Shroyer-EMS

Mr. Shroyer attended the meeting to discuss the need for another ambulance. He currently only has six of his eleven vehicles operating today. Mr. Shroyer asked if he could defer his Maximus payment to the General fund in 2018 and pay it after he receives his first half settlement in 2019. If the payment is deferred he could purchase another vehicle by Friday of this week. The Commissioners approved his request.
