### CECA-Injection Well Opposition

Jim Kettler, Nick Teti, Marlene Zeigler, Pete Madsen, Marie Madsen, Emily Granes, Glen Mullett, Norma Ownes,. Karen O'dell, Julie Brode, Roberta Kettler, Sandra Durbin, Ellen Lauvry, David Graham, Loran Lauvry, Tom Dile, Andrea Thomas, Robert Brems, Steve Tumblin,. Lynn Wilson, Robert West, Evan Ehman, Ann Bordenkircher, Penny Patterson, Jim Karas, Ernie Galajda, Barbara Teti, Jill Baumgardner, Carol Macario, Terri Owen all attended the meeting to express their concerns on the Class I Injection Well. Mr. Kettler read a Resolution that the CECA Board of Directors passed in opposition of the well. He stated that they had 1900 signatures from individuals of the community. Mr. Teti stated that the Commissioners could send an appeal to the Environmental Review Appeals Commission prior to the permit being granted. By doing this they could delay the injection well up to one year. Barbara Teti, Roberta Kettler and Karen O'Dell all expressed their concerns against the Class I injection well. Mr. Jim Karas questioned each Commissioner if they would each go on record and state their position on the well before the Committee and the media.

Mr. Fischer stated that beginning in June the Commissioners were doing research on the issue and letters have been written to our Representatives, Senators, Ohio EPA and ODNR regarding citizens' concerns. The Commissioners also had an article in the Beacon that had all of the letters that they had written. Roberta. Kettler asked if the Commissioners planned to attend the hearing to voice their position during the public comment period. Mr. Shryock stated that the Commissioners had conversation last week regarding writing a letter on their position and it was their understanding that a letter held the same merit as speaking at the hearing. They understood that they would have until October 26, 2018 to submit the letter.

### Bid Opening

At 10:00 a.m. bids for the EMS Central Office Renovation were opened with the following persons present: Mr. Todd Shroyer, EMS Director, Jody Copp, Beaver Construction, William Albert and Don Wells, Albert Excavation. The only bid received was from Beaver Construction with a bid of \$1,100,000.00. Mr. Shryock asked for the Engineer estimates, Mr. Shroyer stated it was \$518,700. Mr. Shryock stated that the Beaver Construction bid would be rejected since it was over 10%. Mr. Shryock asked Mr. Shroyer to go back to the architect and re-evaluate the project and then get back with them for further instruction.
