EMS Bid Discussion

Mr. Todd Shroyer attended the meeting at the request of the Commissioners to discuss options for proceeding with the bid process on the new EMS Building Remodel. Mr. Shroyer stated that he has been trying to determine what happened with the bid. He stated that he spoke with some local contractors and found that there was a lot of confusion with the bid. He stated that the individuals that submitted the bid would like to do a Construction Manager at Risk (CMR) for this project. He is doing some research on this to determine if it would save some funds. He also determined that we can save a lot of money if we take the new roof out and leave the HVAC on the roof. He is finding out that the roof is a very costly endeavor. He stated that he would like to wait for a few weeks and start a new process. Mr. Fischer asked if we need a new architect. Mr. Shroyer stated that he has looked at this, but is not sure this is necessary. Mr. Shryock asked if the drawings had been approved by Mid-East Building. Mr. Shroyer stated that they had not been approved. He then asked if contractors were able to get in touch with the Engineer with questions. Mr. Shroyer stated that he thought they had a difficult time contacting him. Mr. Shryock then asked if there were 30 addendums to the bid specifications. Mr. Shroyer stated that there were a lot of addendums. Mr. Lee asked what the contract amount for this engineer was. Mr. Shryock stated that it is around \$50,000.00. Mr. Shryock stated that since this bid has come out, we realize that we are not contractors, nor architects; therefore, we should hire a consultant to represent us. We feel that we should have our consultant work with the architect and or engineer on this project and keep Mr. Shroyer from having to deal with this. Mr. Lee asked Mr. Shroyer what is the maximum that he can spend on this building. Mr. Shroyer stated that he was hoping not to be over \$750,000. The Commissioners stated that they will contact the consultant to determine if this project is viable and then determine where to go next with this project.
