Ms. Jennifer Austin attended the Commissioners meeting to present the Coshocton County Library's 2018 Annual Report. Ms. Austin stated that she believes that they have more patrons using their services than ever. The digital use is up 59% over 2018, wireless users are up 1.4%, and they offered over 661 programs at the library. She stated that their levy funds are being used for additional digital library availability, physical book collection and offering Hoopla (instant borrow digital movies, music and eBook's). They have also extended the hours of operation. The Commissioner's thanked her for attending.
