Discussion - Mr. Tim Kettler

Mr. Tim Kettler attended the meeting to discuss some legislation that will impact us. He feels the Commissioners will have a method to deal with this. He stated that it is legislation about brine as a commodity. It will remove all tracking and there will no longer be the need of a resolution to be spread. He stated that Ohio Department of Natural Resources (ODNR) has tested this material and he presented the Commissioners with the results as well as his testimony with the House on this issue. He feels this is a major surface discharge. He stated that the results showed that it was highly radioactive. He stated that ODNR then had Ohio Department of Health (ODH) test it and they came back with higher results than ODNR. Their concerns are that we have to be very proactive against this and the Commissioners have the ability to help with this. He has a lot of concern about our tourism trade and we need to have a much more effective partnership between the Board of Commissioners and the Health Board.

DJFS Update - Mr. Danny Brenneman

Mr. Brenneman then reviewed some of the programs at DJFS. In January 2018 there were 6,129 individuals on SNAP Food Assistance and in December of 2018 there were 5.507 individuals. That is a 10% decrease. He also stated that of those work eligible individuals there were 11 receiving cash assistance and required to do a work activity. That number has continued to go down over the last 10 years. The Commissioners thanked Danny for his update.

CT Consultants

Mr. Mike Carder and Mr. Mike Miller, CT Consultants attended the meeting to introduce CT Consultants new employee, Mr. Mike Miller.
