## Dog Wardens Report

Received the Dog Warden's report for the week ending April 22, 2019 with 4 dogs picked up by the warden, 1 dog brought in as a stray, 2 dogs euthanized, 11 dog licenses sold, 3 late fees paid, 9 dogs sold, 2 dogs redeemed, 7 dogs per owner surrendered, \$5.00 in boarding fees collected, 12 citations issued, and 33 phone calls handled for a total of \$308.00 in fees collected.

#### CORSA Renewal/Review

Mrs. Brooke Alverson, Coshocton County Safety and Loss Control, Ms. Sheri Barbowski, CORSA, Mr. Tony West and Mrs. Jill Carnes, Jacobs Vanaman Agency attended the meeting to present the CORSA Renewal and Review. Ms. Barbowski stated that our invoice went down a little over \$1500 from last year. That is very good since we actually increased our exposure over last year. We were able to get some Loss Fund Dividends back and 100% of our incentive programs this year and also received some property excess dividends. She then reviewed some of CORSA 2019-20 Program Enhancements. The addition of Schedule 1 and 2 substances controlled under Federal law, cleanup removal & disposal; Land Banks (2 options); and Drones. She then reviewed the Law Enforcement and Cybersecurity Programs that are included and lastly, she went over the CORSA Stewardship Report which is an overview of the Risk Management Services the County utilized last year. Mr. West then talked about increasing the general liability limits. He provided the pricing structure for this. He then reviewed the Program Cost Allocation for the 2019-20 year. He reiterated that our exposure is up over last year. The Commissioners thanked everyone for attending and Mrs. Alverson for her work with CORSA and Jacobs Vanaman Agency.

#### Permissive License Fee

Mr. Frederick T. Wachtel, County Engineer also questioned the Commissioners thoughts on his request to increase the Permissive License Fee. Mr. Lee stated that the Commissioners have decided that they will table this request at this time.
