Mr. Chris Wilson, Southeast Ohio Building Department

Mr. Chris Wilson attended the meeting to talk to the Commissioners about May being International Building Safety Month. He works for Washington County although he resides in Coshocton County. With the blessing of his Commissioners he is here to talk with the Commissioners about Southeast Ohio Building Department supplying these services to Coshocton County. He stated that at Southeast Ohio, they do everything electronically. With that being said, there is no lag-time at their department. They have found that contractors are happy with this process. Also, when they receive an application, their software will out-reach to other public entities that will need plan approval as well. He stated that they also communicate with the Fire Departments. This is something new in the Ohio Revised Code. He would like to provide these services for Coshocton County. He stated that he has already spoken with the City of Coshocton's Mayor and the City Service Director about this change as well. He stated that he would like to set-up a drop station in Coshocton. Mr. Shryock asked how many counties they take care of. Mr. Wilson stated Washington, Noble, Guernsey and some of Belmont Counties Villages. Mr. Shryock then asked if we have any local contractors that we can ask for references. Mr. Wilson stated that he does not believe we have any here in Coshocton as they do not work that far south. However, he would like the Commissioners to ask the local contractors what type of services they are getting now. Mr. Shryock then asked about the fee structure. Mr. Wilson stated that the fee structure is the same for the general public as well as the public entities. He stated that their fee structure is higher than Mid-East. However, he is taking these additional monies to provide equipment and employees to do a better job. The Commissioners thanked him for attending and stated that they will take this under advisement and get back with him.
