Mr. Jason Baughman, Mid-East Ohio Building Department attended the meeting to discuss the County's Contract with them. He stated that he understands we have been approached by another building department and wanted to make certain the Commissioners understand what they provide. He stated that we have contracted them since 1999. He presented their fee schedule along with their competitor's fee schedule. The competitors are about 25% higher than Mid-East Ohio Building Department. He stated that they are a local building department and he has a good relationship with the local entities in Coshocton County. They want business owners to call and ask them questions if they are unsure of how to go about things. He stated that they do not have the software to allow contractors to submit online. It is very expensive and most of the time people trying to submit the applications do not understand what is required and end up calling them anyway. He stated that they have been assured that within six months they will be able to accept drawings online and he is pleased with that. Mr. Shryock asked how if any do they serve the Amish community. Mr. Baughman stated that it is very challenging at times, but once the find out there is a project, they work with them on what is needed. He is not sure how to market to them differently that just finding them. The Commissioners thanked him for attending and will continue their contract with Mid-East Ohio Building Department.
