Executive Session Cyber Security

At 10:01 a.m. Mr. Shryock made a motion, seconded by Mr. Fischer to go into executive session with Mr. Mike LaVigne, Mrs. Stephanie Slifko and Mrs. Brooke Alverson to discuss Cyber Security. All vote aye. At 10:45 a.m. Mr. Lee returned the meeting to regular session. No action taken.

EMA Update – West Lafayette

Mr. Robbie McMasters and Mr. Troy Cole attended the meeting to update the Commissioners on the West Lafayette area storm damage. Mr. Lee stated that it has been requested by the Mayor of West Lafayette that EMA go to all the houses in the affected area to assess the damage. Mr. McMasters stated that a lot of the information was provided with the questionnaire that they sent out to all residents. However, depending on the amount of time the Commissioners would like them to put in to this they could go back out if they would like them to. He feels that we need to be very careful in doing this though. Mr. Frederick T. Wachtel and Ms. Jessica Goodsell attended the meeting as well to offer any assistance the Tax Map Office and the County Engineer's Office can offer. He stated that they can create a map of the damaged area with the addresses of these homes. Mr. Shryock asked of the 140 homes damaged, does Mr. McMasters have the addresses for those homes. Mr. McMasters stated that they have 90 some addresses from homes they actually assessed and the rest are from phone calls. Mr. Shryock asked if he had a dollar amount on the 90 homes they assessed. Mr. McMasters stated that they did not. Mr. Cole stated that there were many people wanting to include personal loss in this disaster. However, the Federal Government only looks at the actual structural loss. Mr. Lee stated that we understand that the Methodist Church is collecting funds for those with loss. If we don't have addresses that show who had damage, then how will they know who needs help. Mr. McMasters stated that the residents that need assistance and are willing to participate will get assistance. Mr. Fischer stated that he feels Mr. McMasters should include the residents that called

in with damage in the list to the Engineer so that they might include them on the map. Mr. Fischer stated that he feels that in the future he should deal with the residents individually and if they want an individual assessment then they should go out and look at it. It might help residents understand the situation better and what is available. Mr. Shryock asked if there is any advantage in us as the government knowing what the dollar amount of loss is. Mr. McMasters stated that he is not certain about that. But, what he does think is that the total loss will be in the millions. Mr. Shryock asked if there was not some type of form we could create and ask the residents to complete so that if something like this would happen in the future we would have a better idea of how to handle the next situation. Mr. Cole stated that maybe they can work with IT to develop a form to do this. Mr. McMasters stated that this has been a learning process for us and they hope to have a meeting with everyone involved once this emergency is over with to make sure they do better in the future. Mr. Fischer stated that he feels that they should still to do the door to door assessments if the residents want that. Mr. Shryock is in agreement with this as anything we can do we should. Mr. Wachtel stated that if we look at all the places water went and the flow, we can then maybe determine a way to change some things to make things better in the future. The Commissioners thanked everyone for attending.
