Child Welfare Attorney Service

Mr. Danny Brenneman, Director, Job and Family Services and Mr. Jason Given, Prosecuting Attorney attended the meeting to discuss the Child Welfare Attorney Service. Mr. Given stated that due to a large increase in their cases not only felony, but child welfare, increasing from 15-20 cases to 100-125 cases that are being litigated for child welfare. It has been determined that they will need to have an additional attorney and staff member to cover these cases. He discussed with Mr. Brenneman this issue and it was determined that Job and Family Services will hire an attorney to cover these types of cases. This is probably the most cost effective and accessible (to the attorney) way to help with this issue. Mr. Given stated that this will have some effect on his funding as he now receives monies to cover these types of cases. However, this will allow them to focus on the felony cases and civil cases that seem to be forever increasing. Mr. Brenneman stated that this will work well as this new hire will be very accessible to the employees and it will help in the preparation of the court cases prior to going to court. At this time they are being reimbursed with Title 4-E funding for the monies being paid to the Prosecutors Office and that will continue to be reimbursed back to the Job and Family Services. He feels they will be able to utilize the staff they have in place to assist this attorney but may possibly have to hire a part-time employee for this purpose. Mr. Given feels like this will be the best logistical and cost effective way to help with this ever growing issue. Mr. Lee asked if Job and Family Services will have enough funding to cover this position. Mr. Brenneman stated the hope is that they will be able to cover the cost for this attorney, but it is still not certain until its determined how much additional funding will come from the State of Ohio. The Commissioners thanked them for attending.
