Meetings Attended

Mr. Lee attended the Township Budget Hearings on August 5th, Mr. Lee, Mr. Fischer and Mr. Shryock attended the County Budget Hearings on August 6th, Mr. Lee attended Ohio Means Jobs Local Advisory Committee on August 6th and Mr. Lee and Mr. Fischer attended the Ribbon Cutting Ceremony for the Farmhaus Restaurant on August 6th.

Discussion - Mr. William Bauers - Courthouse Sandstone

Mr. William Bauers, Quality Masonry Company, Mr. Ike Reger, County Maintenance and Mrs. Robin Schonauer, Budget Director attended the meeting. Mr. Lee welcomed everyone and stated that Mr. Bauers was here to talk to us about the state of the sandstone at the courthouse. Mr. Bauers stated that the company he works for is a small company and they primarily focus on stone masonry repair/replacement. He stated that there is not that many issues with the brick at the courthouse. It appears relatively alright. He stated that with the sandstone we do have some issues. He explained where the issues are and that some of the issues need to be addressed immediately. He prepared a summary of each elevation and highlighted those areas that he felt needed attention. He broke his work down into groups of necessity. Some of the work needs to be addressed very soon. He then discussed how they would do these repairs with patches. He also explained that the patches are not a 100 year fix. He stated that he would probably suggest the use of pre-cast stone vs. natural stone because of the cost. He stated that there will not be a difference in the look of the courthouse at all. He then talked about other ways to provide strengthening the stone and he feels that we would benefit greatly from this. Mr. Lee asked how many companies are out there doing what they do. Mr. Bauers stated that there are some companies like theirs, but very few. Mr. Shryock asked what the life expectancy of a pre-cast stone is. Mr. Bauers stated 50-75 years. Mr. Lee asked how soon they could mobilize on a section that needed work immediately. Mr. Bauers stated that they could probably get one section mobilized this year, but if we wait a couple weeks, we would definitely be into next year. Mr. Shryock asked if we bid the whole project out, how long it would take to be completed. Mr. Bauers stated right around 3-5 months. The Commissioners thanked everyone for attending.
