Appointed Counsel Fee Schedule

Mr. Jeff Mullen, County Public Defender attended the meeting to discuss the necessity to increase the Appointed Counsel Fees. Mr. Mullen stated that he sent a chart over that was prepared last week by the Ohio Public Defenders Office. On the chart, the smaller counties have the most trouble getting appointed counsel. He stated that the Commissioners should talk with Judge Blanchard as he is having a very difficult time getting attorneys. The attorneys we draw here in Coshocton are mostly from other counties as most of the local attorneys are connected in some way. He stated that there was as study done on appointed counsel and it was determined that an attorney needed to charge \$75.00 per hour to break even on cases. He then explained the procedure to get reimbursement from the State Public Defenders Office. He stated that the State is recommending the rate of \$75.00. Mr. Shryock asked if we increase our fee schedule, would this enable us to get attorneys more readily. Mr. Mullen stated that he is not certain. Mr. Lee asked if he would recommend the increase and Mr. Mullen stated that based on the information he has and working with the local judges, he would recommend the increase. The Commissioners thanked him for attending and providing the information.
