Discussion – 2020 Capital Funds Requests

Mr. Garry McAnally, Mr. Kent Staker, Wachtel & McAnally Architects, Sheriff Timothy Rogers, Captain Dean Hettinger, Lt. Charles Udischas, Mrs. Beth Cormack and Ms. Tyra Hixon, Behavioral Health Choices attended the meeting to discuss a request by the County Commissioners Association and Buckeye State Sheriffs Association for information on our plans for a new Justice Center to be submitted with other counties for possible State Capital Funding. Mr. Lee thanked everyone for attending. One of the questions asked was they requested a cost for the facility. Mr. McAnally stated that they hope to have everything we need back to us by Thursday, November 7th. He stated that costs have been increasing but that was expected. He stated that recently a 48 bed facility cost 21 million dollars. Mr. McAnally stated that he thought the last number of beds that was discussed was 148 bed facility. The Commissioners thought the number was a 132 bed facility. Mr. McAnally stated that what they will do is put some numbers together for a 132 bed facility as well as 148 beds. He also stated that the female population is going up and that may need to be looked at. He then stated that we have one classroom and he suggests that we need to add an additional

classroom. Sheriff Rogers then asked about single cell vs. dorm style housing. Mr. Staker stated

that in the last conversation they had they had made these changes. Mrs. Cormack then reviewed some of the treatments that they are giving to the inmates at this time. However, with the way the Justice Center is now they are unable to administer many of their services while they are in the Justice Center. She and her staff have the programs, but they are unable to administer them. Mr. McAnally asked Mrs. Cormack to please put all she said in writing to submit with the County's request for funding as he feels this will help. He stated that the budget is limited, but we need to make certain we are putting the right things in the construction plans. Mr. Udischas reviewed additional programming they would like to have as well. The Commissioners thanked everyone for attending and we look forward to hearing from Wachtel & McAnally with their numbers and programming capabilities.
