CCAO - Solar Energy

Mr. John Leutz, CCAO, Mr. Bob Snavely, Palmer Energy, Mr. Frederick T. Wachtel, County Engineer and Mr. Josh Kempf, County Engineer's Office attended the meeting to discuss the CCAO Energy Program and the addition of Solar Energy. Mr. Snavely presented the Commissioners with some information on the new Solar Program. Mr. Leutz then stated that this started because several counties were interested in the option of solar energy. They are working on a power purchase agreement for solar energy. They have 44 counties signed on at this point and would like to give Coshocton County the opportunity as well. This would be a 10 year contract with a 10 year renewal and is a fixed price for the term of the contract. The City of Cincinnati recently did the same thing. It is anticipated that our price will be below 3.7 cents per kilowatt hour (this does not include the capacity charge). If the number is not that low, they will not bring the contract to them. Once the agreement has been negotiated with the developer, they will come back to the county and at that time the county can still decline if they so choose. They feel now is the best time to get into this and they are looking at this as a hedge to future energy costs. They expect there to be a slight premium to begin with for the generation costs. Mr. Lee asked what we are paying per kilowatt hour at this time. Mr. Snavely stated Coshocton County is paying 4.117 per kilowatt hour and that includes the capacity charge. Mr. Snavely stated that when they started this project they were looking at 200 megawatts, and now we are looking at 400 megawatts. Mr. Lee asked when is the deadline to sign on to do this. Mr. Leutz stated that they would like the decisions made by the end of August. Mr. Shryock stated at this point he understands that this is a good faith initiative at this point. Mr. Leutz agreed. Mr. Lee asked when this would start and Mr. Snavely stated it would be at the end of our next contract. The solar will also only be on approximately 20-25% of our total kilowatt usage. The Commissioners thanked them for attending.
