Mrs. Brooke Alverson, County Safety and Loss Control also attended the meeting. Ms. Redmond reviewed the Stewardship Report and the coverage enhancements from 2010 to 2020. She then reviewed the counties premium costs for the past 10 years. She stated that they are able to keep the county's costs down due to the programs that have been instituted as well as the members working hard to put these programs in place. While our premium costs have decreased, our total insured values have increased. She highlighted some enhancements that have been made to increase the coverage of the county. Coshocton County has member equity returns in the amount of \$354,672. She reviewed the risk management services and discussed how this affected us over the past year. Mr. Brownlee stated that they do have a membership meeting coming up on September 24th and we will need to vote on some issues at this meeting. He also discussed some requirements or mandates he feels will be coming down to counties that we need to be concerned about with our coverage. These mandates will deal with our Sheriff's Departments mainly. He also wanted to assure the Commissioners that they will continue to work hard to save monies for the counties. The Commissioners thanked them all for attending the meeting.

Meetings Attended


