Teleconference – Dr. Robert Gwinn – Para-medicine

Dr. Robert Gwinn called in to discuss the possibility in starting a Para-medicine Program with in the Coshocton County EMS. He would like to utilize this for individuals that are having COVID issues and monitor their progress as they are released from the hospital or to help individuals determine if they need to go to the hospital. This could be expanded after COVID to look at other medical issues to determine a way to monitor those patients once they go home or help them determine if they need to seek additional medical attention. This program is very well established around the United States and they will need to hire 2 additional EMT's to monitor the patients. He stated that the program will cost approximately \$150,000, and they hope to get \$75,000 from DJFS and they are requesting \$75,000 from the Commissioners through CARES Funding. Mr. Shryock asked about funding this in the future and how it would be done. Dr. Gwinn stated that for the first few years it will need to be grant funded. The CARES monies and DJFS being available now, it would help get this started earlier than intended. Mr. Fischer asked if there would be any costs to the patients. Dr. Gwinn stated that there will be no charge to the patients. Mr. Lee asked if we will be able to get this done within the required time period. There was general discussion on the ability to get the monies encumbered and the program in motion in the allotted time. Dr. Gwinn stated that he is hoping to have this up and running by the first of the year and he feels they may develop the system to help up to about 60 patients per month. Mr. Fischer stated that we need to talk with Mrs. Schonauer to discuss funding, but should be able to get back with him by the first of next week. The Commissioners thanked him for his call.

Meetings Attended

Mr. Fischer attended the Regional Airport Board Meeting on November 19th, Mr. Fischer also talked with Jason Baughman at Mid-East Ohio Building Department about utilizing the Mayors offer and have a local office in Coshocton open 2 days per week. He then contacted Mayor Mills to let him know of this possibility. The Mayor is excited about this possibility.
