Discussion – DJFS – Foster Care Costs

Mr. Danny Brenneman and Mrs. Robin Schonauer attended the meeting to discuss Foster Care Costs in the County. Mr. Brenneman stated that the number of cases have continued to increase in 2020. He also stated that what has also continued to increase is the cost per child. He stated that as of 2020, they have paid \$2,254,000 in funds for Foster Care. He stated that he is here today to ask the Commissioners if they can pull funds from the general fund to help pay for this. Mr. Fischer asked when they put the levy on requesting additional funds. Mr. Brenneman stated that it was in 2018 and it failed approximately 52% to 48%. It was a .4 mill additional levy and would have generated right around \$350,000. He then asked how much he is asking for in general fund dollars. Mr. Brenneman stated he would ask for \$200,000. He stated that this is a crisis that many counties are having across the state. Mr. Fischer then asked if he has a thought process of possibly going back and asking for additional funding via levy. Mr. Brenneman stated that if the Commissioners feel this is prudent then he will do so. Mr. Shryock asked if this is a general fund obligation if there is no funding to pay this. Mr. Brenneman stated that it is. Mr. Shryock then stated that this 2 million dollar obligation could end up bankrupting the county. He also stated that it would have been very helpful for us to have this information prior to December of last year. We would probably not given the funds to the general fund that were given for 2021 departments had we been aware of this. We will have to look into see what funds are available in order to determine if we will have to pull some monies back from other general fund departments. Mr. Shryock then asked if Mr. Brenneman has been in contact with Senator Hottinger in regards to this issue and the need for additional funding. The Commissioners thanked him for attending and stated that they will take this under advisement.
