Annual Enterprise Zone Meeting - Via Zoom

Mr. Dane Shryock, Mr. Rick Conkle, Mr. Gary Fischer, Ms. Sherry Kirkpatrick, City Representative, Mrs. Tiffany Swigert, Coshocton Port Authority, Ms. Christine Sycks, County Auditor, Mr. Dalton Summers, River View Schools, Mrs. Lee Jane Williamson, River View Schools, Mr. Tom Crawford, McWane, Mrs. Kelli Darr, McWane, Mrs. Jody Wright, Kraft Foods and Mrs. Tammy Hess, Coshocton County Career Center.

Mr. Shryock asked for the approval of the minutes. Ms. Sycks made a motion, seconded by Mr. Summers to approve the minutes from the last Enterprise Zone meeting. All vote aye. Motion Carried.

Ms. Sycks made a motion that we do not have a Vice Chairman for 2021. Seconded by Mr. Fischer. All vote aye. Motion carried.

Mr. Shryock then turned the meeting over to Ms. Sycks. Ms. Sycks then addressed the following tax abatements:

McWane Poles (McWane, Inc.) -100% (12 year) with PILOT for tax years 2014 through 2025, inclusive with a 1.5 million real estate roofing/renovations investment, 12 new, full-time employees and annual wages of \$424,320. The McWane Plies Enterprise Zone is in place is currently receiving an annual abatement of 100% on the new construction for this project through 2025 tax year (payable in 2026). The tax saving for tax year 2021 is \$34,721.75.

Ms. Kelli Darr, McWane stated that they had a 33% increase in revenue and increased employees and payroll. They paid River View Schools and the Career Center their PILOTS. She briefly reviewed the number of poles made and the renovations made. She stated that in 2021 they will be celebrating the McWane Centennial. Mrs. Swigert congratulated them on their continued success.

Ms. Sycks stated that the Review Council is instructed by statute to determine whether the owner of the exempted property has complied with the agreement and may take into consideration any fluctuations in the business cycle unique to the owner's business. She then entertained a motion to continue, modify or cancel. Mr. Mr. Shryock made a motion, seconded by Ms. Kirkpatrick to continue the Enterprise Zone. All vote aye. Motion carried

Ms. Sycks then reviewed the next Enterprise Zone; Kraft Food Groups, Inc. (General Foods Corp.) – 75% (10 year) for tax years 2016 through 2025, an annual wages of \$8.736 million. The Kraft Food Groups, Inc. Enterprise Zone is in place and is currently receiving an annual abatement of 75% on the new construction for this project through 2025 tax year (payable in 2026). The tax savings for tax year 2020 is \$37,873.17.

Mrs. Jody Wright, Kraft Foods, stated that they continue strong production with 133 million pounds of bacon made in 2020 and in 2021 they are set to make 141 million pounds. At the end of December 2020 they had 640 employees. They are currently forcing their employees to work 60 hours per week as they have an inability to hire and keep employees. They are above in the agreed payroll payout. In 2020 they started hiring employees and hired 240 employees and have since terminated 200. They have 77 open positions at the facility at this time. They continue to struggle on their weekend shifts and are working with many entities to fill the open positions. They have contact negotiations coming up and hope to increase wages. They hope that this change will help them become be able to fill all the open positions.

Ms. Sycks stated that the Review Council is instructed by statute to determine whether the owner of the exempted property has complied with the agreement and may take into consideration any fluctuations in the business cycle unique to the owner's business.
