2nd Public Hearing – CARES Act Funding – New EMS Building

At 10:00 a.m. Mr. Dane Shryock opened the 2nd Public Hearing with Mr. John Cleek attending the meeting via teleconference. Mr. Cleek stated that this is a required public hearing for Cares Act funding and we will be applying for 2,577,000 of cares act funding and 1,0500,000 of local funding for a total project in the amount of \$3,627,000.00 he will submit the grant and we should hear back from the State of Ohio by June of 2021. If we receive the grant funding, requested monies, it will be a 2 year project ending by December 2023.

2nd Public Hearing – ODOT Grant Proposals

At 10:30 a.m. Mr. Shryock opened the public hearing with Ms. Valerie Shaw, CCCTA Director in attendance. Ms. Shaw explained that she is applying for funding of the ODOT 5311 which is a 50% match and she is requesting funding for her capitalized maintenance as well as she is also applying for 2 vehicles. The Mobility Management grant funding is being requested as well. Her total local match will be \$489,000.00 for all grant requests. She will know if she gets her grant funding in late summer. At 10:50 a.m. Mr. Shryock closed the public hearing.
