Comp Time/Overtime Computation

Mr. Conkle made a motion, seconded by Mr. Fischer to make a change to the Comptime/Overtime Computation for County Employees as follows: Non-exempt employees are entitled to overtime pay whenever they work in excess of 40 hours in a work week. For purposes of computing overtime, the County will include time spent actually working, vacation leave, personal leave, holidays and sick leave used for pre-scheduled medical appointments. Time spent on sick leave other than for pre-scheduled appointments shall not count. In addition, any employee who is authorized or required to work on a recognized holiday will be paid at 1.5 times their hourly rate for hours worked on the holiday in addition to their holiday pay. There shall be no pyramiding of overtime.

Executive Session-Michael Zaluski


