Montrose


Mr. Tim Biggam and Mr. Dave Robinson from The Montrose Group presented the Commissioners with some opportunities within our county they feel we could benefit from locally. They also wanted to touch-base with us and receive feedback from the county on current projects that are ongoing (Justice Center). They both agreed that Governor DeWine found communities that really could benefit greatly with jail grant funding and they were both pleased to see Coshocton County be one of the few grantees of the Justice Center Grant. The State Legislation is trying hard to help communities obtain more resources for county prisons/programs. Economic Development and the Public Policy are working jointly to advocate for local communities. Mr. Robinson asked about our challenges locally, as they may be able to help with those challenges or facilitate meetings with those who could help. However, until the new legislative maps are final, it is difficult to know who we will be working with in Coshocton County. Mr. Shryock gave kudos to Mr. Kevin Miller who is our representative and is very involved locally. Mr. Robinson asked if we possibly had any Capital Bill request that he could help with as well as Federal Budgets earmarks. It was stated that April is the time to apply for those federal budget grants if we so choose to do so. Projects are taken through a portal and the Us House and Senate have put out some guidance to help with those requests. There was much discussion on the Kirk Drain in West Lafayette, if this is a possible federal grant project as the Commissioners would like to help SWCD find a funding sources for this issue. A follow up discussion is to be at a later date. The Commissioners need to think long term as how to position the county with the growth coming this way from the Columbus area, there are plenty of sites locally to develop here and the possibilities look good for Coshocton. Mr. Shryock thanked both gentlemen for their presentation and time.


Meetings Attended


