Bid Opening-Engineers Office-TR 337 Bridge 1 Replacement Project

At 9:00 a.m. bids for the TR 337 Bridge 1 Replacement Project were opened with the following person in attendance: Mr. Travis McConnell, McConnell Contracting, Inc., Mrs. Brandy Scott, BUDS, Inc., and Mr. Joshua Kempf, Assistant County Engineer. Mr. Shryock read the following bids aloud: McConnell Contracting, Inc. with a bid of \$188,489.00 and BUDS, Inc. with a bid of \$193,938.20. Mr. Shryock made a motion, seconded by Mr. Conkle to turn all bids for the TR 337 Bridge 1 Replacement Project to Mr. Joshua Kempf, Assistant County Engineer for review and recommendation.

Ohio TT- Update

Mrs. Megan Kvamme, Mr. Kyle Yoder, Mr. Matt Armstead and Mr. Justin Embrey presented the Commissioners with an update on Ohio TT in Coshocton County, also in attendance were Mr. Rusty Dreher and Mrs. Robin Schonauer. As of current, Millcreek is the only live site up and running for Ohio TT with 8 active customers and 15 on a waiting list to be added onto the tower. Mr. Yoder stated the balance of the other co-location sites should be ready by the end of July with the variable being MARCs. However, Ohio TT was able to get in touch with Mr. Dick Miller, who works for the State of Ohio and MARCs and start conversations to help facilitate their relationship on towers together. After speaking with Mr. Miller yesterday as well as email communication they are very optimistic that progress will move much faster now on the tower sites. It is very beneficial to both Ohio TT and MARCs to work directly together on this project. In addition, Ohio TT has all equipment in their possession that is needed for all tower co-locations. All existing towers should be active by the end of June or first of July with roughly 300 customers hooked in. Each tower site moving forward will be handling in the same manner. Mr. Yoder was pleased to announce that roughly 75% of customers should/will be able to be served on the towers, and of those who are not able to be served there will be added to a list of those as well so that those locations can be re-addressed at a later date. The 25% who are not in locations to have service are usually in valley areas in the county. Ohio TT is looking for additional land in the county on private lots to lease for new tower sites in the following townships: Bedford, Washington, Pike, Lafayette, Woodbury Area, Adams and NW Jackson, rates for the leasing of land have been set as of now. As of now, little marketing has been done for Ohio TT, however they will be sending out postcards, using yard signs and placing billboards throughout the county in the coming months.




Adjourn
