Melanie Leneghan-Roof Connect

Mrs. Melanie Leneghan and Mr. Ken Beck both representing Roof Connect presented the Commissioners' with a proposal to complete three (3) of our county roof projects (Annex, Probate and the Courthouse) with a base bid of \$271,163.00. Roof Connect is interested in the project and are a national company who are aware of build codes and other issues that could come up on projects such as these. As well, with Roof Connect being a National Company, and Co-Cop they are able to offer national pricing on their bids. Roof Connect will also offer an extended warranty on all roofs that would extend pass the manufacturer warranties. All OSHA standards will be followed if they are awarded the projects. The quote given out today is good for 30 days. Mrs. Beck stated that the quote is \$37,000.00 under Mr. Pat Kelly's estimate. Mr. Shryock thanked both Mrs. Leneghan and Mr. Beck for their presentation.

Mr. Shryock adjourned the meeting at 12:00 p.m.



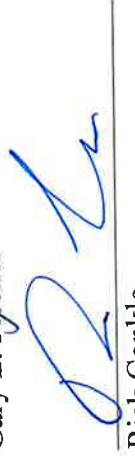
